# ADMINISTRATOR'S REPORT - Theresa Adkinson

**Financial Update & COVID-19 Costs** – To date \$35,000 has been spent on response for COVID-19. There is the possibility of funding but no definite numbers. Per CDC there should be approximately \$560 million to local public health. GCHD is maximizing exempt staff as well as non-exempt staff with priority being keeping staff healthy. Incident Command Service (ICS) was activated on March 2 due to confirmed cases. This does include Grant County Emergency Management and GCHD meeting for daily briefings, assignments and working with our commissioners.

## HEALTH OFFICER'S REPORT - Dr. Brzezny

**Influenza Update** – Influenza A had a recent increase and now seeing it flatten. Increase in positive Influenza results are in part to more testing being done to rule out COVID-19.

**SSP/HAV Update** – Flier in packet, there continues to be Hep A outbreaks we must continue to work with county jails on vaccinating inmates.

**COVID-19 (Coronavirus Response)**—Power point presentation by Dr. Brzezny, discussion held. Public health emergency implication reviewed. Social distancing and proposed non-pharmacological interventions reviewed in detail.
