Well Log or Well Report

GCHD requires lab reports with satisfactory coliform and nitrate level for all water systems except Group A or Group B public systems.

Types of Water Systems

Group A Public Water System

Large water systems with greater than 15 service connections or serves greater than 25 people per day

.....

Group B Public Water System

Small water system with less than 15 connections and serves less than 25 people per day.

.....

Same Farm Exempt Water System

Water system that has four or fewer residential connections and serves people working for or owning the same farm

.....

Shared Well Water System

One well shared between 2 residences

.....

Private Water System

One well serving one residence, OR, one connection serving less than 25 people per day.

A Guide to Completing the Application

Determine the type of water system you have.

Use the left panel and the second page of the Water Availability Review Application to help you. Pay special attention to the top box on the second page of the application.

.....

Group A and Group B Public Water Systems

The purveyor of the water system must complete and sign section 1) b. of the application. The purveyor can be found by contacting the water system administrator.

.....

Shared Well

Along with a copy of the well log and certified water lab results, be sure to include a copy of your shared well agreement. The agreement must be recorded to title on each parcel involved.

Same Farm Exempt

Along with a copy of the well log and certified water lab results, be sure to include a copy of your "Same Farm Affidavit" that has been recorded to title.

Individual Well

Include a copy of your well log and certified water lab results.
