Mission Statement

On September 19, 2023, members of the North Central YCCTPP gathered for an in-person meeting in Omak, WA. During the meeting, participants discussed work plan objectives and updates, as well as collaborated to create an updated mission statement.

CANNABIS: FACTS CAREGIVERS SHOULD KNOW

Why do young individuals start using cannabis?

- Curiosity, peer pressure, and a desire to fit in with peers are common reasons that youth begin use.
- Individuals who already smoke cigarettes and/or consume alcohol are at increased risk for cannabis use as well.
- Those who have untreated mental health disorders or who have experienced trauma are at increased risk for using cannabis at an early age.
- For many, substance use starts as a way to cope, but being high is also seen as a way to simply avoid the problems and challenges of growing up.

YOUTH VAPING: CBD

According to the 2022 National Youth Tobacco Survey from the FDA and CDC, over 2.5 million middle and high school students are vaping.

The effects of vaping cannabidiol (CBD) don't tend to be common knowledge. When someone vapes CBD they are ingesting more than just CBD. CBD oil in vapes is almost always paired with other chemicals for flavor and often nicotine – both of which present danger. Vaping CBD (and other substances) primarily affects the lungs and heart and is linked to both lung and heart disease.

Regular vaping of CBD can lead to (but not limted to) popcorn lung, compromised immune health, lung disease, and even death.





Locking Bags/Boxes

The North Central YCCTPP continues to partner with organizations in the region to provide lockboxes to locals.

The Grant County Health District (GCHD), TOGETHER! for Youth (TFY!), and the Okanogan County Community Coalition (OCCC) are available to answer questions related to safe storage and provide locking bags and boxes.

E-CIGARETTE REGULATIONS - WA

This is a summary of WA state laws; cities, counties, and Tribes may have other measures in place.



PACKAGING REGULATIONS: LIQUID NICOTINE

<u>Liquid nicotine</u> containers *must* be child-resistant.

All liquid nicotine containers must be labeled with a warning regarding the harmful effects of nicotine, a warning to keep the vapor product away from children, a warning that vaping is illegal for minors, and for open systems, a disclosure of the amount of nicotine in milligrams per milliliter, along with the total volume of the container in milliliters.



ACCESS RESTRICTIONS

Sale/distribution of vapor products to persons under age 21 is prohibited. <u>Wash. Rev. Code § 26.28.080(1) (2023)</u>

Purchase/possession of vapor products by persons under age 18 prohibited. <u>Wash. Rev. Code § 70.345.140(1)</u> (2023)

Self-service displays of vapor products prohibited except in retailers inaccessible to persons under age 21. <u>Wash. Rev. Code § 70.345.080 (2023)</u>

VERBAGE

E-Cigarettes are **not** included in any section of Washington State's statutes in the definition of "Tobacco Products".

E-CIGARETTE REGULATIONS - WA

This is a summary of WA state laws; cities, counties, and Tribes may have other measures in place.



ACCESS RESTRICTIONS

Samples of vapor products must take place within licensed retail premises that is restricted to those over the age of 21 years, contain no nicotine (unless "customer explicitly consents"), and use a disposable mouthpiece. <u>Wash. Rev. Code §</u>. <u>70.345.100 (2023)</u>

Free vapor product distribution prohibited without contemporaneous purchase of vapor product. Wash. Rev. Code § 70.345.110 (2023)



Sale of vapor products containing vitamin E acetate prohibited. <u>Wash. Admin. Code § 246-80-</u> <u>021 (2023)</u>

Delivery sales of vapor products prohibited unless seller has a valid delivery sale license, verifies the age of the purchaser through a third-party database, and only accepts payment through a credit or debit card in the purchaser's name. <u>Wash. Rev. Code § 70.345.090(1)-(7) (2023)</u>

SALES

A retail license or permit is required to sell e-cigarettes. <u>Wash. Rev. Code §</u> <u>70.345.030(1)(a)</u> (2023)

RESTRICTIONS

E-Cigarettes

Use of vapor products in and on grounds of child care facilities, schools, playgrounds, school buses, elevators, and within 500 feet of schools is prohibited. <u>code</u>.

Vaping is prohibited in indoor early learning facilities, vehicles used to transport children, and outdoors on property during nonbusiness hours in a place that would not be considered a "public place" and at least 25 feet from entrances, windows and vents. <u>code</u>.

Use of electronic smoking devices on State veteran home campuses prohibited (except for residents authorized to smoke prior to the no smoking rule or in designated outdoor smoking areas). <u>code</u>.

DRUG DEBRIEF

WHAT IS XYLAZINE?

Xylazine is a non-opiate sedative (induces a state of sleepiness), analgesic (pain reliever), and muscle relaxant authorized for veterinary use in the U.S.


OTHER NAMES

Street Names: Tranq, tranq dope. Trade Names: Rompun and AnaSed.

What is its Origin?

Xylazine was first synthesized in 1962 by Bayer. Xylazine was first noted as an adulterant (mixed with other substances) in Puerto Rico in the early 2000s.





Complications of Xylazine Use

Repeated injection of xylazine (alone or with other substances) can present skin abscesses that can lead to tissue death. Amputation rates are higher among those who inject drugs mixed with xylazine.

Physical Dependence

Users of xylazine may develop a physical dependence to the drug. Some users report withdrawal symptoms as, or more, severe than from heroin or methadone; symptoms can include sharp chest pains and seizures.

Treatment

When combined with fentanyl or other synthetic opioids, xylazine can increase the potential for fatal overdose. Xylazine has no approved antidote for human use.

OVERDOSE EFFECTS

Suspected xylazine-induced overdose may involve dry mouth, drowsiness, high BP, and increased HR - Followed by low BP, decreased HR, hypothermia, coma, respiratory depression, irregular heart beat, etc.

BP - Blood Pressure, HR- Heart Rate

<u>Naloxone</u>

If a xylazine overdose is suspected, naloxone is still recommended (even though it is a non-opioid), as xylazine is often mixed with opioids (fentanyl and heroin typically).

Xylazine Legal Status

Xylazine is not currently a controlled substance under the U.S. Controlled Substances Act.

PREVENT MISUSE

Safety, Storage, and Disposal Tips For Everyone

Prescription and over the counter medications can be both helpful and harmful. By keeping medications out of the wrong hands and ensuring that they are used correctly, we can help keep everyone safe from accidental ingestion and medication misuse.

What is Medication Misuse?

- Taking someone else's medication
- Taking too much of a medication
- Not taking prescribed
 medication
- Using medication any other way that how it is intended to be used

WHAT YOU CAN DO

- Talk Talk to the youth in your life about the dangers of medication misuse.
- Lock Meds Up The safest medications are secured medications.
- Take Note Monitor the number of pills or doses remaining of the medications in your home.
- Dispose Safely dispose of expired , unneeded, or unwanted medications at drug take back days, mail-back programs, disposal sites, etc.
- Be prepared in case of an emergency Poison Control: 800–222–1222


